

## **Privacy Policy**

This Privacy Policy ("Policy") applies to <https://www.cumberlandpainting.com/>, and Cumberland Painting, LLC. ("Company") and governs data collection and usage. ### **Collection of your Personal Information**

In order to better provide you with products and services offered, the Company may collect personally identifiable information, such as your:

## **Sharing Information with Third Parties**

## **Right to Deletion**

- Exercise free speech, ensure the right of another consumer to exercise his or her right of free
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public in
- Enable solely internal uses that are reasonably aligned with your expectations based on your
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with
